Once again it is time for the illustrious 'CHEESE HEADS' to plan another get together (this marks the 21th year of this annual event). Eric Van Miller has once again offered his facility for our meeting at his office in Green Bay. So make your plans to attend the Advanced Biomechanics XXI Course. For participants of previous 'Biomechanics' courses this program will be a combination of clinical techniques with direct correlation of specific treatment problems through the use of case presentations.

For the past few years I have ask the group to submit ideas for topics for the next year's course. This results in numerous request to answer specific questions regarding specific treatment problems and I have attempted to group these together in order of the most requested items. One popular subject was for tips and comparisons of various Class II techniques on treating Class II cases in the mixed and permanent dentition. So we will look at and compare (tx criteria, appliance placement and adjustments and treatment responses) for various fixed and functional Class II techniques (including, bionators, twin blocks, Forsus, elastics and distalizers). A second had to do with 'thin slicing' extraction cases (including when to take teeth out and which teeth to take out including treatment criteria for lower incisor extractions and management of congenitally missing teeth in extraction cases). There were also a high number of questions related to practice management issues. Additionally, there was (once again) the request to see more tips and tricks that I have acquired over the last 30+++ years of

orthodontics. Equally important in this category was the interest in seeing relapse cases and what to do about them as well as things that didn't work. So this year's seminar will seek to address these items (including answering some of the specific questions that were asked). See the list of 'Clinical Learning Objectives' below.

This will not be a repeat of last year's information.

Multiple cases will be utilized to demonstrate various aspects of mechanics and treatment modalities with particular interest paid to the best available 'evidenced based information'.

Additionally, multiple treatment 'pearls' will be shown to make your practice easier and more efficient.

Participants Case Consultations

Participant's individual cases will be reviewed at 5:00PM on Friday and 1:00PM on Saturday after the course. *Please respect the 2 case maximum.* Should you decide to bring the records on a case from your office, be sure that it has been completely traced, analyzed, and treatment planned prior to our discussions. In order to give you an opinion, it is necessary that you present complete and accurate records, and that you follow the "analytical and cephalometric guidelines" previously set.

- 3) Lower incisor extraction cases (not just for Class III cases) when and why.**
- 4) Dealing with malposed second molars espically those erupting late in the case.**
- 5) When is it time to take the braces off???**
- 6) Learn multiple 'pearls' for practice management of orthodontics in a non speciality practice dealing with patients and parents.**
- 7) Dealing with open bite cases in the mixed and permanent dentition.**
- 8) Periodontal and mucogingival problems including frenectomies.**
- 9) Long term retention protocol, results and criteria.**
- 10) Current info on WSL and OH considerations.**
- 11) Multiple individual topic including: single tooth torquing auxiliaries, midline correction, phase I tx for blocked out cuspids, different expansion appliances, space maintenance and tips on aligner treatment.**
